No Purchase or Obligation Necessary to enter or win.

## **CONTEST DESCRIPTION:**

**Registration**: Weekdays beginning Friday May 17<sup>th</sup> at around 5:20pm through Friday May 24<sup>th</sup>, 2024, at around 8:30am. (Contest Period)

**Requirements**: Must be 21 years of age or older and have a valid Arizona Driver's License or Government Issued Identification Card.

**Grand Prize**: Five (5) separate individual winners will be awarded four (4) Disneyland Resort 2-Day, 1-Park per day tickets, and a three-hundred dollar (\$300) prepaid gift card to use for gas or travel; tickets provided by Disneyland® Corporation and the travel gift card provided by Arizona Lotus Corporation for promotional purposes. (ARV: \$610)

**HOW TO ENTER/WIN:** Listeners of KMXZ who are legal residents of the 48 contiguous United States residing within the Tucson, Arizona metropolitan area will be able to take part in the KMXZ – Disneyland Resort Tickets Contest. To participate in the KMXZ – Disneyland Resort Tickets Contest, listeners must do the following:

- 1. Beginning Friday May 17<sup>th</sup> through Thursday May 23<sup>rd</sup>, 2024, at around 5:20pm, a KMXZ (94.9 MIXfm) DJ will give a Disneyland® Resort "Pixar" keyword to text into the KMXZ (94.9 MIXfm) contest line, 520-775-0949.
- 2. From Monday May 20<sup>th</sup> through Friday May 24<sup>th</sup>, 2024, at around 7:30am, the KMXZ (94.9 MIXfm) morning show will randomly announce a name selected from the qualified registered text entries. The person announced during this time will have until around 8:30am to call into the KMXZ (94.9 MIXfm) contest line, 520-775-0949, to officially become the *Grand Prize* winner. If the person announced does not call in, at or before 8:30am, then the KMXZ (94.9 MIXfm) morning show will take caller #9 to be that day's *Grand Prize* winner.
- 4. Grand Prize winners will have until June 24th, 2024, at 5pm to pick claim their tickets and gift card.

#### **ELIGIBILITY RESTRICTIONS:**

1. The KMXZ – Disneyland Resort Tickets Contest is open to listeners of KMXZ who are 21 years of age and older and are legal residents of the 48 contiguous United States residing with the Tucson, Arizona metropolitan area.

2.
