To participate in the KMXZ – 94.9 MIXfm Morning Show 12 Purses of Christmas Contest, listeners must do the following:

1. Starting Monday December 2nd, through Friday December 20th 2024 at 7:10am, KMXZ (94.9 MIXfm) DJ’s will be instructing listeners to log on to www.mixfm.com and click on the “94.9 MIXfm Morning Show 12 Purses of Christmas contest” tile to view the photo gallery of the available purses and its corresponding numbers 1 through 12. When prompted on 94.9 MIXfm each weekday at about 7:10am during the Contest Period, except for December 12th & 13th, call the KMXZ studio contest line at (520) 775-0949 and be caller #10 for a chance to win. The eligible caller #10 will have the chance to select one (1) purse from the gallery of available purses by telling the DJ the corresponding number for that preferred purse. Plus, at the same moment, the DJ will also reveal the additional bonus prize attached to that selected purse.
2. Daily winners will be selected each weekday morning at about 7:30am during the Contest Period except for December 12th & 13th, 2024. Winner will be contacted on same date via phone and/or email and will have until January 20th, 2025, to claim prize.

ELIGIBILITY RESTRICTIONS:

1. The KMXZ – 94.9 MIXfm Morning Show 12 Purses of Christmas Contest is open to listeners of KMXZ who are 18 years of age and older and are legal residents of the 48 contiguous United States residing with the Tucson, Arizona metropolitan area.
2. Employees of KLPX, KCMT, KFMA, KTKT, KMXZ, KFFN, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KMXZ – 94.9 MIXfm Morning Show 12 Purses of Christmas Contest.
