KMXZ - BEACH BOYS CONCERT CONTEST RULES

No Purchase or Obligation Necessary to enter or win.

CONTEST DESCRIPTION:

Registration: Beginning Monday 1/13/25-Sunday 1/19/25. (Contest Period)

Requirements: Must be 18 years of age or older and have a valid Arizona Driver's License or Government Issued Identification Card.

Prize: Ten (10) winners will be awarded two (2) digital tickets for the Beach Boys Concert on May 3rd, 2025, at the AVA Amphitheater at Casino Del Sol I in Tucson, AZ; provided by Casino Del Sol for promotional purposes. (ARV \$30)

HOW TO ENTER/WIN: Listeners of KMXZ who are legal residents of the 48 contiguous United States residing within the Tucson, Arizona metropolitan area will be able to take part in the KMXZ – Beach Boys Concert Contest. To participate in the KMXZ – Beach Boys Concert Contest, listeners must do the following:

- 1. Beginning Monday January 13th, through Sunday January 19^{th, 2025}, a KMXZ DJ will be giving out the KMXZ contest texting number (520-775-0949) and a keyword.
- 2. Each listener who texts during these cues will be automatically registered for the opportunity to win the *Prize*. Message & Data Rates May Apply.
- Winners will be randomly selected from the registered participants, on Monday, January 20^{th.}, 2025, and will be contacted via phone call and/or email.
- 4. Winners will have digital ticket link(s) emailed to them by no later than May 2nd, 2025, at 5pm.

ELIGIBILITY RESTRICTIONS:

- 1. The KMXZ Beach Boys Concert Contest is open to listeners of KMXZ who are 18 years of age and older and are legal residents of the 48 contiguous United States residing with the Tucson, Arizona metropolitan area. Participants must have a valid email and smart phone, in case of winning the prize; tickets can only be claimed through email and used at venue via smart phone. The process to claim and use tickets is as follows: Arizona Lotus Promotions department will send ticket link(s) to the winner's email. Winner must open email on a smart phone and click on link(s), winner will then be directed to open the "Ticketmaster" app on their smart phone, where they will see the digital barcode they must present at the venue. If the winner does not have the "Ticketmaster" app, then the winner must download the app and create a profile. Winners cannot attempt to print ticket link or ticket code because it will not be accepted at venue.
- 2. Employees of KLPX, KCMT, KMXZ, KTKT, KMXZ, KFFN, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KMXZ Beach Boys Concert Contest.
