

## KMXZ – Visit to the DISNEYLAND RESORT OCT/NOV 2025 CONTEST RULES

No Purchase or Obligation Necessary to enter or win.

### CONTEST DESCRIPTION:

**Registration:** Beginning Monday, October 20<sup>th</sup>, 2025 through Friday, October 31<sup>st</sup>, 2025. (Contest Period)

**Requirements:** Must be 21 years of age or older and have a valid Arizona Driver's License or Government Issued Identification Card.

**Prize:** Nine (9) separate individual winners will be awarded four (4) Disneyland Resort 2-Day, 1-Park per day tickets; tickets provided by Disney Destinations. (ARV: \$1,320)

**Grand Prize:** One winner will be awarded a Disneyland Resort grand prize for a family of four (4), which includes, a two (2) night stay at Disneyland hotel/resort, three-day park tickets for a family of four (4) to be used once per day at either Disneyland or California Adventure. Disneyland Resort hotel and ticket package provided by Disney Destinations LLC (ARV: \$3,312)

**HOW TO ENTER/WIN:** Listeners of KMXZ who legal residents of the 48 contiguous United States are residing within the Tucson, Arizona metropolitan area will be able to take part in the KMXZ – Disneyland Resort Contest OCT/NOV 2025. To participate in the KMXZ – visit to the DISNEYLAND RESORT OCT/NOV 2025 CONTEST RULES, listeners must do either of the following:

### TEXT TO WIN

2. Each listener who texts during these cues will be automatically registered for the opportunity to win the **Prize**. Message & Data Rates May Apply.
3. Four (4) Winners will be randomly selected from the text registered participants, on Tuesday, November 4<sup>th</sup>, and will be contacted via phone call and/or email.

### LIVE- CALLER #9

1. Beginning Monday November 3<sup>rd</sup>, through Friday November 7<sup>th</sup>, 2025, Rob & Joss in the Morning will take caller #9 as the winner of a four (4) Disneyland Resort 2-Day, 1-Park per day tickets, one winner per day

### GRAND PRIZE- DISNEYLAND RESORT TRIP CONTEST

4. During the Contest Period, KMXZ (94.9 MIXfm) DJs, and recorded announcements, will be instructing listeners to log on to [www.mixfm.com](http://www.mixfm.com) and click on the "DISNEYLAND RESORT TRIP CONTEST" tile to complete a contest registration form which includes contact information, name, phone number, email, and date of birth. *\*Only one entry per IP address will be allowed during contest period.*
5. On Tuesday, November 11<sup>th</sup>, 2025, one (1) Grand Prize winner will also be selected randomly from quailed website entries. Grand Prize winner will be contacted via phone call and/or email on this same date.
6. **Prize** winners will have until December 31<sup>st</sup>, 2025, at 5pm to pick claim their tickets and gift card. **Grand prize** winner contact information, phone number and/or email, will be given to the Disneyland Corporation promotions department and will reach out to the Grand Prize winner within fourteen (14) to twenty-one (21) calendar days to book the dates and details of the trip. *\*Any changes or claims to reservations and use of tickets will be at the discretion of Disneyland Corporation; Disney Corporation rules for this contest at the end of these Arizona Lotus promotion contest rules.*

#### **ELIGIBILITY RESTRICTIONS:**

1. The KMXZ – visit to the DISNEYLAND RESORT OCT/NOV 2025 CONTEST is open to listeners of KMXZ who are 21 years of age and older and are legal residents of the 48 contiguous United States residing within the Tucson, Arizona metropolitan area.
2. Employees of KLPX, KFMA, KMXZ, KTKT, KCMT, KFFN, KLPX-HD-3, Arizona Lotus Corp, and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KMXZ – DISNEYLAND RESORT OCT/NOV 2025 CONTEST.
