To participate in the KMXZ – Rob & Joss' 12 PURSES OF CHRISTMAS 2025 CONTEST, listeners must do the following:

1. Starting Monday December 8<sup>th</sup>, through Friday December 19<sup>th</sup>, 2025 at 7:45am, KMXZ (94.9 MIXfm) DJ's will be instructing listeners to log on to [www.mixfm.com](http://www.mixfm.com) and click on the "94.9 MIXfm Morning Show 12 Purses of Christmas contest" tile to view the photo gallery of the available purses and its corresponding numbers 1 through 12. When prompted on 94.9 MIXfm each weekday at about 7:45am during the Contest Period, except for December 13<sup>th</sup> & 14<sup>th</sup>, call the KMXZ studio contest line at (520) 775-0949 and be caller #9 for a chance to win. The eligible caller #9 will have the chance to select one (1) purse from the gallery of available purses by telling the DJ the corresponding number for that preferred purse. Plus, at the same moment, the DJ will also reveal the additional bonus prize attached to that selected purse.
2. Daily winners will be selected each weekday morning at about 7:45am during the Contest Period except for December 13<sup>th</sup> & 14<sup>th</sup>, 2025. Winner will be contacted on same date via phone and/or email and will have until January 8<sup>th</sup>, 2026, to claim prize.

**ELIGIBILITY RESTRICTIONS:**

1. The KMXZ – Rob & Joss' 12 PURSES OF CHRISTMAS 2025 CONTEST is open to listeners of KMXZ who are 18 years of age and older and are legal residents of the 48 contiguous United States residing with the Tucson, Arizona metropolitan area.

2.
