

KCMT - DISNEYLAND JAN/FEB 2026 CONTEST OFFICIAL RULES

No Purchase or Obligation Necessary to enter or win.

CONTEST DESCRIPTION:

Registration: Weekdays, starting Monday January 26th through Friday February 27th, 2026. (Contest Period)

Requirements: Must be 21 years of age or older and have a valid Arizona Driver's License or Government Issued Identification Card.

Grand Prize: Five (5) separate individual winners will be awarded five (5) Disneyland Resort 2-Day, 1-Park per day tickets provided by Disneyland Resorts . (ARV: \$1,675)

HOW TO ENTER/WIN:

Listeners of KCMT La Caliente who are legal residents of the 48 contiguous United States residing within the Tucson, Arizona metropolitan area and are 21 years of age and older will be able to take part in KCMT - DISNEYLAND JAN/FEB 2026 CONTEST. To participate in the KCMT - DISNEYLAND JAN/FEB 2026 CONTEST, listeners must do the following:

1. Listen to KCMT weekdays during the **Contest Period**, to hear the "*Disneyland*" sounder cue-to-call. When you hear the "*Disneyland*" sounder cue-to-call, phone into the KCMT contest line at 520-719-0921. Each caller #9, during each "*Disneyland*" sounder cue to call, will be registered for the opportunity to win the **Grand Prize**.
2. One (1) **grand prize** winner will be randomly selected from the registered qualifiers on **each** Monday during the contest period, starting Monday, February 2nd, 2026, and will be contacted via phone call and/or email.
3. Grand Prize winners will have until March 31st, 2026, to claim prize.

ELIGIBILITY RESTRICTIONS:

1. The KCMT - DISNEYLAND JAN/FEB 2026 CONTEST is open to listeners of the Station who are 21 years of age and older and are legal residents of the 48 contiguous United States residing with the Tucson, Arizona metropolitan area.
2. Employees of KFMA, KCMT, KLPX, KTKT, KMXZ, KFFN and KLPX HD3, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KCMT - DISNEYLAND JAN/FEB 2026 CONTEST.
