

## **KMXZ, KLPX, KFMA, KFFN & KLPX-HD3 – MISSION: COOL IMPOSSIBLE A/C GIVEAWAY 2026 OFFICIAL CONTEST RULES**

No Purchase or Obligation Necessary to enter or win.

### **CONTEST DESCRIPTION:**

Registration: Beginning Monday, August 24th through Sunday, September 6th, 2026. (Contest Period)

Requirements: Must be 18 years of age or older and have a valid Arizona Driver's License or Government Issued Identification Card. Must reside in the Tucson Metro Area, be a homeowner, and have authority to install an air conditioning unit.

Grand Prize: One (1) winner will be awarded a new American Standard Silver 15 split system or Silver 13 package system, as appropriate for the winner's home, up to a 5-ton system for a home up to approximately 2,200 square feet; standard installation; and an UltraViolet (UV) full-home purification system; provided by Signature Heating and Cooling for promotional purposes. Standard installation is included at no cost provided the winner has an existing A/C system and existing ductwork, electrical service and other standard infrastructure required for installation. (ARV: Over \$20,000)

**HOW TO ENTER/WIN: Listeners of KMXZ (94.9 MIXfm), KLPX (96.1 KLPX), KFMA (Rock 102.1 KFMA), KFFN (ESPN Tucson 1490 AM) and KLPX-HD3 (93.3 HANK FM) who are legal residents of the 48 contiguous United States residing within the Tucson, Arizona metropolitan area will be able to take part in the Mission: Cool Impossible A/C Giveaway 2026. To participate, listeners must do the following:**

1. 2. Limit one (1) entry per person per day during the Contest Period, regardless of which participating station website is used to enter. Entries submitted through more than one participating station website by the same person on the same day will not provide additional entries and may be disqualified.

3. One (1) Grand Prize winner will be randomly selected after the conclusion of the Contest Period from all eligible entries received through all five (5) participating stations combined. The selected winner will be contacted via phone and/or email no later than September 10, 2026. The selected winner will have five (5) days from the date of initial notification to respond and claim the prize. If the selected winner does not respond and claim the prize within five (5) days, the prize will be forfeited and another winner will be randomly selected.

4. Selected winner's home will be inspected by Signature Heating and Cooling prior to final award and installation to confirm eligibility, system requirements and installation conditions.

5. Winner must claim the prize and coordinate installation with Signature Heating and Cooling. Installation must be scheduled and completed by December 31, 2026.

### **ELIGIBILITY RESTRICTIONS:**

1. The Mission: Cool Impossible A/C Giveaway 2026 is open to listeners of KMXZ, KLPX, KFMA, KFFN, KLPX-HD3, KTKT and KCMT who are 18 years of age and older, are legal residents of the 48 contiguous United States residing within the Tucson, Arizona metropolitan area, and are homeowners with authority to install the prize.

2. Employees of Signature Heating and Cooling, KLPX, KCMT, KFMA, KTKT, KMXZ, KFFN, KLPX-HD3, Arizona Lotus Corp. and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the

1. Selected winner's home will need to be inspected prior to the prize being awarded. The residence must be able to accommodate the applicable American Standard Silver 15 split system or Silver 13 package system, up to 5 tons, for a home up to approximately 2,200 square feet.

2. Standard installation is included at no cost only when the residence has an existing A/C system and the necessary existing ductwork, electrical service and other standard infrastructure. Additional non-standard modifications or upgrades are not included in the prize.

3. The Grand Prize also includes an UltraViolet (UV) full-home purification system provided by Signature Heating and Cooling.

4. To the extent that prize elements are provided by third-party providers, winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.

5. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by station management and/or the sponsor in its sole discretion.
