

OFFICIAL CONTEST RULES MOTHERS DAY TWIN CONTEST

THE MOTHERS DAY TWIN CONTEST STARTS 12MIDNIGHT APRIL 15, 2019 AND ENDS 1159PM MAY 8, 2019.
