WATCH TO WIN GIVEAWAY SWEEPSTAKES

In return for the opportunity to participate in the Watch to Win Giveaway Sweepstakes described herein (the "<u>Sweepstakes</u>"), Rocket Ball, Ltd. (the "<u>Houston Rockets</u>") and SportsNet Southwest, LLC, d/b/a Space City Home Network ("<u>Sponsor</u>") require your agreement to comply with and be bound by the terms and conditions set forth below (the "<u>Official Rules</u>").

OFFICIAL RULES
