Motion by Diamond to Approve Consent Agenda. Seconded by Fistler. The Board authorized AGWSR's administration to submit a request to the School Budget Review Committee (SBRC) in the amount of \$266,764 for MSA for open enrollment out students not included on the prior year count, on a motion by Fistler, seconded by Scallon; carried 6-0.

The Board authorized AGWSR's administration to submit a request to the School Budget Review Committee (SBRC) in the amount of \$7,031 for MSA for providing an English language learner program for students who have exceeded five years of weighted funding, on a motion by Diamond, seconded by Minteer; carried 6-0.

Motion by Scallon, seconded by Fistler to approve the second and final reading as presented of Board Policy 502.10-Use of Motor Vehicles as presented; carried 6-0.

Motion by Diamond, seconded by Scallon to allow using an electronic signature or signature stamp or signature stamp of the board president for official's contracts that are assigned by AGWSR based on the rates provided; motion carried 6-0.

Supt. Smith discussed the final results of the recent bond vote. It was agreed to move forward with adding the vote to the November 2025 election. Moving forward Smith will be working with ICAT (Iowa Construction Advocate Team) who is an affiliate program with IASB (Iowa School Board) to assist and provide support.

Motion by Scallon to approve the grade configuration changes as presented below effective 2025-26 school year.

- \*All K-4 students attend AGWSR Elementary in Ackley
- \*All 5-8 students attend AGWSR Middle School in Wellsburg
- \*All 9-12 students attend AGWSR High School in Ackley
- \* No change to Cougar's Den or Little Cougar Playhouse.

Motion was seconded by Metzgar and carried 6-0 on a roll call vote Fistler-yes, Metzgar-yes, Minteer-yes, Diamond-yes, Scallon-yes, Meyer-yes.

Supt. Smith is beginning to work through the FY26 budget. The board discussed the direction they would like to see.
