Mayor has spoken with the Belmond Hospital and they are agreeable to coming to Meservey, it is only 2 miles outside of their district. Mayor has also spoken to Mason City Fire Department and they also understand and would be agreeable. Council questions include whether residents could be given a choice from the dispatcher when they call? Would we have to pay Belmond to come here? Could Mason City agree to transfer to Belmond if asked? Would like a representative from Belmond Ambulance to come to the next council meeting.

Gobeli wonders who we could get to put up the Christmas lights? There have been a couple of complaints. The guys who usually do it are getting older and are more nervous about being lifted up in a tractor bucket. Clerk gave them a number for an Alliant Energy employee that put up lights in Rowan and Alexander. They will give them a call!
