## PROCEEDINGS OF THE FRANKLIN COUNTY BOARD OF SUPERVISORS

The Board of Supervisors met at 8:30AM on Monday, January 20<sup>th</sup>, 2025, at the Franklin County Courthouse with Board members Lukensmeyer, McVicker, and Vanness present.

Motion by McVicker, seconded by Lukensmeyer to approve the Agenda as presented. All ayes. Motion carried.

Motion by Lukensmeyer, seconded by McVicker to approve the regular minutes from 1/13/2025 as well as budget workshop minutes from 1/14/25, 1/15/25, and 1/16/25. All ayes. Motion carried.

Public Comment & Board Committee Updates: Lukensmeyer attended Board of Conservation.

Jay Waddingham, Secondary Roads Engineer, met with the Supervisors to provide them an update on his department.

Motion by McVicker, seconded by Lukensmeyer to approve an Iowa Department of Transportation Federal-Aid Agreement for a county highway bridge program project on 40<sup>th</sup> Street over Beaver Creek (BROS-C035(122)-8J-35). All ayes. Motion carried.

Motion by McVicker, seconded by Lukensmeyer to open a public hearing pertaining to a New Construction Permit Feeding Permit Application for Pantheon Farms LLC in Section 18 of Hamilton Township at 9:15AM. All ayes. Members of the public present were: Becky Sexton & Jim Luebbers with the farm. No comment had been received prior to the meeting. Motion by McVicker, seconded by Lukensmeyer to close the public hearing at 9:19AM. All ayes. Motion carried. Motion by Lukensmeyer, seconded by McVicker to approve a new construction feeding operation permit application for Pantheon Farms LLC. All ayes. Motion carried.

Mary Perry was not able to attend, but Assessor, Carissa Sisson, and Real Estate Deputy, Amy Holmgaard explained that the Homestead Tax Credit had been in place for many years prior to 2023. At that point the Assessor's office received notice from the post office that the home was vacant, which was why it was removed. However, Perry still lives in the home. After brief discussion, motioned by Vanness, seconded by McVicker to reinstate Mary Perry's Homestead Credit for the 2023 & 2024 assessment years and waive the late fee. All ayes. Motion carried.

Andrea Miller, County Attorney, met with the Supervisors regarding her budget for FY2026.

A department head meeting was held at 10:00AM. Minutes may be obtained by contacting the Auditor's office.

The Supervisors recessed at 10:30AM for a drainage meeting. They reconvened at 10:45AM. Drainage minutes may be found on the County website or by contacting the Auditor's office.

Mary Amsbaugh, Franklin County Development Association Director, met with the Supervisors to provide them an update on happenings in her organization and discuss her request for funding during FY2026.

Audrey Emery, Human Resource Director, met with the Supervisors regarding COLA Increases for FY2026 and Elected Officials Compensation for FY2026. Motion by McVicker, seconded by Lukensmeyer to approve a 2.4% COLA increase effective 7/1/25. All ayes. Motion carried. There was also discussion regarding employee contribution rates for health insurance and elected officials' compensation for FY2026. Both will be on next weeks agenda for further discussion and possible action.

Motion by McVicker, seconded by Lukensmeyer to approve claims as submitted. All ayes. Motion carried.

Motion by Lukensmeyer, seconded by McVicker to approve a resolution authorizing various transfers. The resolution reads in full:

## RESOLUTION 2025-05 A RESOLUTION AUTHORIZING OPERATING & CAPITAL PROJECTS TRANSFERS FOR VARIOUS FRANKLIN COUNTY DEPARTMENTS

**WHEREAS**, Franklin County, Iowa (the "County"), pursuant to and in strict compliance with all laws applicable to the County, desires to transfer cash from one fund to another for the purposes of supporting several county entities. **WHEREAS**, presently the County has budgeted monies for the following transfer:

Motion by McVicker, seconded by Lukensmeyer to approve a resolution establishing public purpose for township trainings. The resolution reads in full:

## RESOLUTION 2025-4 ESTABLISHING PUBLIC PURPOSE FOR TOWNSHIP TRUSTEE TRAINING

WHEREAS, FRANKLIN COUNTY DOES HAVE 16 TOWNSHIP TRUSTEES & CLERKS LEADING THE VARIOUS TOWNSHIPS; AND WHEREAS, THE FRANKLIN COUNTY BOARD OF SUPERVISORS & THE FRANKLIN COUNTY AUDITOR FEELS IT IS IN THE BEST INTEREST OF THE PUBLIC TO PROVIDE TRAININGS AND MEETING FOR THE TRUSTEES & CLERKS TO BETTER UNDERSTAND THEIR RESPONSIBILITIES; AND WHEREAS, THE FRANKLIN COUNTY BOARD OF SUPERVISORS & FRANKLIN COUNTY AUDITOR MAY HOLD CERTAIN WORKSHOPS/TRAININGS TO HANDLE ISSUES THAT WILL AFFECT TAX DOLLAR EXPENDITURES AND REVENUES; AND THEREFORE, THE FRANKLIN COUNTY BOARD OF SUPERVISORS FIND THAT THE EXPENDITURES FOR FOOD & BEVERAGES AND TRAINING MATERIALS MAY BE FURNISHED TO THE TOWNSHIP TRUSTEES & CLERKS FOR THE PREVIOUSLY MENTIONED WORKSHOPS & TRAININGS. Motion by Lukensmeyer, seconded by McVicker to table a resolution adopting a 28E Agreement with Central Iowa Juvenile Detention Center. All ayes. Motion carried.

The Supervisors acknowledge the Sherriff's monthly report for December 2024.
