Motion by Lukensmeyer, seconded by McVicker to approve the agenda as presented. All ayes. Motion carried.

Motion by McVicker, seconded by Lukensmeyer to approve the regular minutes from 4/14/2025. All ayes. Motion carried.

Public Comment & Board Committee Updates: Lukensmeyer attended Board of Health and CICS. McVicker attended Cherokee Mental Health and Central Iowa Juvenile Detention Center.

Jay Waddingham, Secondary Roads Engineer, met with the Supervisors to provide them an update on his department.
