April 22, 2026

The regular board meeting was called to order by President Justin Clark at 5:30 p.m. in room #109. Board members present were Phil Barnett, Justin Clark, Megan Hoodjer, Brandon Kampman and Shelley Maiers; others present were Superintendent Bryan Boysen, Business Manager/Board Secretary Shellee Bartlett, PK-12 Principal Kristi Hannemann and 7 visitors.

Moved by Maiers, seconded by Henrichs, to approve the agenda. Carried unanimously.

Public hearing on 2026-27 certified budget was called to order at 5:30 p.m. No public response was received. The meeting was closed at 5:31 p.m.

Moved by Kampman, seconded by Barnett, to approve the minutes from March 2026 meetings. Carried unanimously.

Moved by Henrichs, seconded by Kampman, to approve March 2026 financial reports and April 2026 monthly bills. Carried unanimously.

Moved by Barnett, seconded by Maiers, to approve the Eagle Scout Project as presented by Noah Sterken for \$5,080 estimate. Carried unanimously.

Mrs. Cindy Gates & Miss Courtney DeMuth presented an overview of the District Career Academic Plan (DCAP).

Abbie Bennett, CEA Representatives, presented the initial proposal from the Clarksville Education Association to the Board of Education for the 2026-27 Master Contract.

Moved by Barnett, seconded by Hoodjer, to approve Budget Guarantee Board Resolution as follows: Resolved, that the Board of Directors of the Clarksville Community School District, will levy property tax for fiscal year 2026-27 for the regular program budget adjustment as allowed under section 257.14, Code of Iowa. Roll: Ayes – Barnett, Hoodjer, Maiers, Kampman, Clark; Nays – None.

Moved by Kampman, seconded by Barnett, to approve the class of 2026 graduates conditional upon satisfactory completion of all graduation requirements from the Clarksville Community School District. Carried unanimously.

Moved by Hoodjer, seconded by Barnett, to advertise old shop items for sale. Carried unanimously

Moved by Hoodjer, seconded by Maiers, to approve adding ag science and forensic science to the course listing. Carried unanimously.

Moved by Kampman, seconded by Barnett, to approve the amended 28E agreement dated effective June 1, 2026 subject to any additional edits required by the Iowa Insurance Division in connection with the Trust's certificate or registration application. Carried unanimously.

Moved by Maiers, seconded by Kampman, to approve the sharing agreement with North Butler CSD for a nurse. Carried unanimously.

Moved by Barnett, seconded by Maiers, to set public hearing date for the 2025-26 amended certified budget for May 18, 2026 at 5:30 p.m. Carried unanimously.
