The regular board meeting was called to order by Board President Ty Crawford-Miller at 6:00 p.m. in the Greene Media Center. Board members present were Ty Crawford-Miller, Dan Engels, Sara Henrichs, Jordan Nolz; other present were Superintendent Bryan Boysen, Business Manager/Board Secretary Shellee Bartlett, Beth Endelman, Bob Bartlett and 3 visitors. Board members absent: Heather Shook.

Moved by Nolz, seconded by Engels, to approve agenda. Carried unanimously.

Moved by Engels, seconded by Henrichs, to approve the minutes from April 2026 meetings. Carried unanimously.

Moved by Nolz, seconded by Engels, to approve April 2026 financial reports and May 2026 bill listing. Carried unanimously.

Moved by Henrichs, seconded by Engels, to approve the following resignation: Renee Salge, prom; Lindsey Windham, cook; Rhonda Edeker, associate; Austin Guerrero, PE teacher, athletic director, softball, basketball; Shiela McCormick, special education teacher: the following recommendations: Kimberly Craig, associate @ \$14.45 per hour; Chase Stohr, junior high baseball @ \$2,019 (BA, step 9, 5%). Carried unanimously.
