DICK BROADCASTING'S CONTEST-SPECIFIC RULES FOR THE 1075 KZL 9 TO 5 PAYROLL CONTEST SPONSORED BY ASPIRE HEATING & COOLING

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

These contest-specific rules should be read in conjunction with Dick Broadcasting's General Contest Rules, which are applicable to all contests conducted by Dick Broadcasting and/or its subsidiaries (including licensee subsidiaries).

- 1. Promotional Period: 1075 KZL 9 To 5 Payroll contest (the "Promotion") begins on or around August 5th 2024, at 9:00 AM and ends at/about 5:00 PM on or about October 27th, 2024 (the "Promotional Period").
- 2. Entry Deadline: The deadline to submit entries is October 27th, 2024 at 5:00 PM.
- 3. Eligibility Restrictions: The Promotion is open to all legal residents of the United States who have a valid state or federal issued I.D. at the time of entry and who live within the station's (WKZL) signal listening area in the following counties of North Carolina and Virginia. The WKZL Listening Area consists of the counties of Alexander, Alamance, Alleghany, Ashe, Caldwell, Caswell, Cabarrus, Catawba, Chatham, Cumberland, Davidson, Davie, Forsyth, Granville, Guilford, Iredell, Lee, Montgomery, Moore, Orange, Person, Randolph, Rockingham, Rowan, Stokes, Surry, Stanly, Watauga, Wilkes, Yadkin in North Carolina and Carroll, Danville, Galax, Grayson, Henry, Martinsville, Patrick and Pittsylvania Counties in Virginia. Contestants may win a hourly and/or daily contest no more than once within any promotional period. Multiple winners from the same household are NOT permitted. Winner's must hold valid United States Driver's License or ID. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from any individual who does not meet the eligibility requirements, and will also delete any entry as required by law.
- 4. Entry Method: To participate in the Promotion, you may enter via the following method(s).

VIA INTERNET and APP – Go to https://1075kzl.com and follow the links and instructions to enter and submit the required information, which may include your first and last name, address, telephone number, date of birth, and a valid email address, in the online entry form. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning the email address or the domain associated with the submitted email address. Multiple entrants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. The contest/sweepstakes administrator's computer is the official time-keeping device for the Promotion.

Limit one (1) entry per email address.

5. Prizes: The total prize(s) jackpot for the entire promotion period will meet or exceed \$9,000.

Individual prizes will range between \$50 and \$9,000 cash.

6. Odds of Winning:

Odds depend upon the number of entries received.

7. Winner Selection and Notification:

Names will be selected randomly from the list of entries submitted on www.1075kzl.com and on the 1075 KZL app. Listen for the cue to call at 9:00 AM, 2:00 PM, and 5:00 PM weekdays during the promotional period. If your name is announced as the qualifier to in the cue to call, you have 10 minutes to answer the cue to call to the 1075 KZL studios at 1-800-682-1075. If you return the cue-to-call within the 10-minute timeframe, you will need to verify your identity by the date of birth listed in your entry. If verified, you will be added to the 1075 KZL Payroll. If you do not return the cue to-call within the 10-minute timeframe, you will not be added to the 1075 KZL Payroll and will no longer be eligible for the contest. If you are added to the 1075 KZL Payroll, you will be awarded \$50. Every cue-to-call at either 9:00 AM, 2:00 PM and 5:00 PM gives another entrant an opportunity to call in and get on the 1075 KZL Payroll. If a qualifier is on the payroll and a cue-to-call passes without another qualifier answering the cue-to-call, the qualifier on the payroll at that time will receive another \$50 for ever cue-to-call until the next cue-to-call is answered.

If there is no answer to the 9:00AM cue-to-call on the first day of the promotion, the jackpot will continue to increase.

At the time of their call entrants must provide all requested information, including their first and last name, complete postal address (street, city, state, and zip code), email address, telephone number, and date of birth. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. The contest/sweepstakes administrator's telephone system is the official time keeping device for the Promotion.
