BOB FM Monthly Business Boost Giveaway

Official Rules

NO PURCHASE REQUIRED TO ENTER OR WIN.

- 1. Eligibility: The BOB FM Monthly Business Boost Giveaway is open to legal residents of Minnesota who are 18 years of age or older at the time of entry. Employees and non-employee workers of Milestone Radio LLC, StarCom LLC, Crystal Broadcasting, Carpenter broadcasting, and their respective parent companies, subsidiaries, affiliates, and agents and those prize providers and agencies that are involved in the development or execution of this giveaway or any of its materials, and the immediate family (spouse, parents, siblings, and children) and household members of each such person are not eligible. The giveaway is subject to all applicable federal, state, and local laws and regulations and is void outside the listed states and where prohibited by law.

- 4. Promotion Period: The promotional period begins at 12:00 a.m. Central Time ("CT"), on January 1, 2026, and ends at 11:59:59 p.m. CT, on January, 2026. Milestone Radio LLC's computer is the official time-keeping device for this giveaway.
- 5. How to Enter: During the promotion period, individuals can enter one business recognized by the state of Minnesota. During each promotional period, entrants must fill out the entry form at mybobcountry.com/monthly-business-boost/ to enter a business into the monthly drawing. As an alternate means of entry, entrants may submit a sheet of paper containing their Name, their email address, their phone number, the business name,

and whether they own, work for, or are nominating the business to the radio station either by mail or in person. Incomplete entries will not be valid.

Limit: Entries do not carry over into the following promotional periods. Participants may only enter once per promotional period. Submitting more than one entry per promotional period will invalidate all entries by that participant. Any entry submitted on behalf of another individual or using another person's email address or name will be disqualified and ineligible to claim any prize. Any attempt by any participant to obtain more than the stated number of entries allowed by using same, multiple/different email addresses, identities, or any other methods void that participant's entries and that participant may be disqualified.

The station reserves the right to move, substitute, or change the advertising schedule as needed, only guaranteeing that all commercials will air on the Total Country BOB FM Network of stations. All commercial copy must be pre-approved by the radio station. Station reserves the right to decline any illegal or inappropriate message. Commercials involving political or issue advertising, as well as commercials promoting the sale of tobacco products, marijuana/cannabis products, or any goods or services whose advertising is prohibited by the laws or regulations of the state or federal government, will be declined.

9. Publicity: Except where prohibited, participation in the giveaway constitutes the entrant's consent for the sponsor, each participating radio station, and its designees to use the entrant's name, likeness, prize information, city

- and state of residence for promotional purposes in any media form without further consideration.
- 10. General Conditions: In the event that the operation, security, or administration of the giveaway is impaired in any way for any reason, including, but not limited to: fraud, virus or other technical problem, the sponsor may, in its sole discretion, either: (a) suspend the giveaway to address the impairment and then resume the giveaway in a manner that best conforms to the spirit of these official rules; or (b) cancel the giveaway and award the prizes in a random drawing from all eligible entries received up to the time of the impairment.
