Operation Rolling Thunder Arrests

August 11, 2025 – August 15, 2025

Devaunte R.Z. Hickman-Young (29)

- Patrol located and arrested Hickman-Young for six separate warrants to include a Felony Warrant for Robbery 1st Degree (\$100,000 BOND); a Felony Warrant for Forgery (3 counts), Money Laundering (2 counts), Theft 2nd Degree (2 counts) and Unlawful Production of Payment Instruments (\$75,000 BOND); a Felony Warrant for Forgery (3 counts), Theft 2nd Degree (3 counts), Money Laundering (3 counts) and Unlawful Production of Payment Instruments (\$75,000 BOND); a Felony Warrant for Identity Theft 1st Degree, Forgery, Theft 2nd Degree and Money Laundering (\$25,000 BOND) and a Misdemeanor Warrant for Assault 4th Degree (\$5,000 BOND).

WARRANT TOTAL BOND \$360,000

Ashley N. Alldredge (35)

- Arrested for three separate warrants: a Felony Warrant for Kidnapping 1st Degree (2 counts), Robbery 1st Degree (2 counts), and Assault 3rd Degree (2 counts) (\$500,000 BOND); a Felony Washington State Department of Corrections Escape Community Custody Warrant related to the original charge of Manufacture/Deliver/Possess a Controlled Substance (\$5,000 BOND); and a Bench Warrant from Grant County related to the original charge of Retail Theft 3rd Degree with Special Circumstances (\$5,000 BOND).

WARRANT TOTAL BOND \$605,000

Olajide A. Fletcher (35)

- SWAT arrested Fletcher after a standoff. He was taken into custody on his two Felony Warrants: Unlawful Possession of a Firearm 1st Degree (3 counts), Possession of a Stolen Firearm, and Assault 4th Degree DV (\$250,000 BOND), and a separate Bench Warrant related to the original charge of Assault 2nd Degree/Weapon and Unlawful Possession of Firearm 1st Degree.

WARRANT TOTAL BOND \$250,000**Martice L. Ryan (25)**

- Ryan was wanted for Murder 1st Degree and Assault 1st Degree. Members of this task force began working on the recent homicide in Pierce County and determined the suspect was in the Spokane area. The task force garnered information that led to his location and arrest by the United States Marshals Service Pacific Northwest Violent Offender Task Force, Tacoma PD, and the FBI in a neighboring jurisdiction. (Critical intelligence was gleaned by a Spokane County Sheriff's Detective, which aided in locating the suspect.)

Anthony W. Herrera (40)

- Herrera was arrested and booked for Felony Charge of Fugitive from Justice, RCW 10.88, related to a Kootenai County Felony Warrant for the original charge of Sexual Abuse of a Child (7 counts).

WARRANT TOTAL BOND \$200,000**Brandon M. Foote (31)**

- Foote was arrested and booked for a Felony Warrant for Unlawful Possession of a Firearm 2nd Degree.

WARRANT - NO BOND**Michael G. Godley (37)**

- Godley was arrested and booked for a Felony Charge of Fugitive from Justice, RCW 10.88, related to a Kootenai County Felony Warrant for the original charge of Robbery.

WARRANT TOTAL BOND \$31,000

Haley A. Smith (36)

- Smith was arrested and booked for a Felony Warrant for Unlawful Possession of a Firearm 2nd Degree.

WARRANT - NO BOND**Nathan J. Molitor (33)**

- Molitor was arrested on his Felony Warrant for Stalking DV-Violate Protective Order.

WARRANT TOTAL BOND \$30,000**Released on Own Recognizance by a Judge****Allson L. Bay (36)**

- Bay was arrested on one Felony Warrant and two Misdemeanor Warrants to include: Assault 2nd Degree DV/Deadly Weapon and Assault 4th DV (\$1,000 BOND); another Criminal Trespass 1st Degree Misdemeanor Warrant from Airway Heights (\$250 BOND), and a final Misdemeanor Warrant for Theft 3rd Degree from Spokane City (\$1,000 BOND).

WARRANT TOTAL BOND \$2,250**Cody F. Wolfley (33)**

- Wolfley was arrested on a NO BAIL Felony Warrant for Parole Violation-Legal Financial Obligation related to the original charge of Residential Burglary and Malicious Mischief 3rd Degree.

Released on Own Recognizance by a Judge**Daniel J. Fouts (55)**

- Information from the Task Force determined Fouts was in Idaho. He was arrested as a Fugitive for Assault of a Child 3rd Degree (Weapon or Negligent Injury). The United States Marshals in Idaho affected his arrest.

Eric S. Buck (46)

- Buck was arrested for a Felony Washington State Department of Corrections Escape Community Custody Warrant related to the original charge of Failure to Register as a Sex Offender.

WARRANT - NO BOND

Warren S. Daniels (43)

- The United States Marshals Pacific Northwest Violent Offender Task Force responded to a request for assistance from the FBI during this operation to locate a violent offender who had absconded from Florida. The Pacific Northwest Violent Offender Task Force and the FBI located and arrested Daniels on a Nationwide Felony Warrant related to the Florida Career Offender Registration Act – Habitual Violent Felony Offender.

Trenton E. Gregory (22)

- Gregory was arrested on a Felony Warrant for Failure to Register as a Sex Offender.

- Osborn was arrested on his Felony Warrant for Burglary 2nd Degree and Theft 2nd Degree.

- Bower was arrested on his Felony Warrant for Burglary 2nd Degree and Theft 2nd Degree (NO BAIL), as well as a Misdemeanor Warrant for Theft 3rd Degree (\$500 BOND).

- Isma was arrested and booked after he tried to elude the Idaho State Police, Washington State Patrol, U.S. Marshals Service, and Spokane Valley Police. He was charged with Felony Eluding, Hit and Run, and Driving Under the Influence/Drugs. The Post Falls Police Department is handling the investigation.

- Peterson was arrested and booked for a Felony Warrant for Assault 2nd Degree/Strangulation.

WARRANT TOTAL BOND \$20,000**Cole L. Healy (42)**

- Healy was arrested on a Felony Washington State Department of Corrections Escape Community Custody Warrant related to the original charge of Assault of a Child 2nd Degree.

WARRANT - NO BOND**Edward J.W. Wynecoop (30)**

- Wynecoop was located and arrested on his Felony Warrant by the Airway Heights Police Department. He was booked for a Felony Washington State Department of Corrections Escape Community Custody Warrant related to the original charge of Assault 2nd Degree.

WARRANT - NO BOND**Christopher D. Hendricks (35)**

- Hendricks was arrested on a Felony Washington State Department of Corrections Escape Community Custody Warrant related to the original charge of Assault 1st Degree – Firearm/Deadly Weapon.

- Traffic Units assisted in stopping and arresting George, who had an extraditable Felony Warrant from Kootenai County, Idaho, related to the original charges of Parole Violation for Grand Theft Property and Grand Theft Receiving Stolen Property. George was also booked on a new felony charge for RCW 10.88 Fugitive from Justice.

- Williams was arrested and booked for a Felony Charge of Fugitive from Justice, RCW 10.88, related to a Kootenai County Felony Warrant for an original charge of Dangerous Drugs. Williams was also booked on two Misdemeanor Warrants for Assault 4th Degree (\$250 BOND) and Possession of Controlled Substance (\$250 BOND).

Amanda N. Addy (37)

- Addy was arrested and booked for a Felony Charge of Fugitive from Justice, RCW 10.88, related to a Kootenai County Felony Warrant for the original charge of Dangerous Drugs.

WARRANT - NO BOND**Alexzander W. Kermano (19)**

- Task Force Deputies located a stolen vehicle. The suspect eventually exited a well-known location and was taken into custody for Theft of a Motor Vehicle. The victim's keys and cellphone were also recovered. Kermano also had a Felony Warrant for Possession of a Stolen Motor Vehicle.

- Young was arrested on two Misdemeanor Warrants: the first for Failure to Comply with an original charge of Animal Cruelty 2nd Degree; the second for Possession of a Controlled Substance.

- Highley was arrested on her Misdemeanor warrant for FTA/Hit and Run Unattended Vehicle.

WARRANT TOTAL BOND \$500**Released on Own Recognizance by a Judge****Nathan D. Johnson (36)**

- Johnson was arrested on his Misdemeanor Warrant for Criminal Trespass 2nd Degree.

Spokane County Jail refused to book-Released**Morgan S. Byrd (31)**

- Byrd was arrested and booked for a Felony Washington State Department of Corrections Escape Community Custody Warrant related to the original charge of Burglary.

- Spokane Valley Traffic and Patrol Deputies assisted in arresting him on two warrants. Misdemeanor Warrant - FTA/DUI and DWLS/R 2nd Degree (\$1,000 bond) and Misdemeanor Warrant - FTA/DUI (\$500 bond).

WARRANT TOTAL BOND \$1,500**Ryan C. Tharp (40)**

- Tharp was arrested on a Misdemeanor Warrant for Failure to Appear on a Criminal Trespass charge. (Pend Oreille County)

WARRANT TOTAL BOND \$500**Jerry L. Everett III (38)**

- Everett was arrested and booked on two Misdemeanor Warrants for Driving on a Revoked License 1st Degree/Habitual Offender.

WARRANT TOTAL BOND \$1,750**Released on Own Recognizance by a Judge****Owen T. Busch (24)**

- Busch was arrested and booked for a Misdemeanor Warrant for Possession of a Controlled Substance.

WARRANT TOTAL BOND \$1,000**Released on Own Recognizance by a Judge**

Michael P. Bracket (34)

- Bracket was arrested and booked on three Misdemeanor Warrants, all related to Theft 3rd Degree (\$1,000 BOND EACH).

WARRANT TOTAL BOND \$3,000**Ashley N. Costich-Scioly (32)**

- Costich- Scioly was arrested on a Misdemeanor Warrant for Failure to Appear on the original charge of No Valid Operator's License without Identification.

WARRANT TOTAL BOND \$250**Ashton B. Lund (31)**

- Lund was arrested on his Misdemeanor Warrant for Theft 3rd Degree. Prior to booking, Naloxone (Narcan) was administered for a possible overdose. Lund was taken to the hospital, where he was eventually medically cleared. The jail refused to book Lund due red-light status. He was released and instructed to go directly to the court window to obtain a recall on his warrant.

Spokane County Jail refused to book-Released**Tony L. Gust (46)**

- Gust was arrested on two Misdemeanor Warrants: the first for Criminal Trespass 2nd Degree, and the second for Possession of a Controlled Substance.

WARRANT TOTAL BOND \$1,000**Released on Own Recognizance by a Judge on both.****Tabatha L. Vanderveer (37)**

- Vanderveer was arrested on two Misdemeanor Warrants for Criminal Trespass 2nd Degree.

WARRANT TOTAL BOND \$500**Released on Own Recognizance by a Judge on both.**

Richard M. Fields (35)

- Task Force Deputies located and stopped a stolen vehicle. The driver, Fields, was booked for Possession of a Controlled Substance with Intent to Deliver. The stolen vehicle and a safe were taken after a search warrant was obtained. **Investigation ongoing.**

- Task Force Deputies located and stopped a stolen vehicle. Chappell was a passenger and was arrested on two Misdemeanor Warrants: the first for Possession of a Dangerous Weapon and the second for Criminal Trespass 2nd Degree.

- Task Force Deputies located a suspicious vehicle and contacted the occupant. Kosloski was arrested for two Misdemeanor Warrants related to Possession of a Controlled Substance.

WARRANT TOTAL BOND \$3,000**Released on Own Recognizance by a Judge****Jesse J. Smith (38)**

- Task Force Deputies assisted in the foot pursuit of the suspect. Smith was caught and arrested for a Felony Washington State Department of Corrections Escape Community Custody Warrant related to the original charge of Felony DUI (3 or more priors within 10 years).
