

2023 BOB FM Chillin And Grillin Giveaway

Official Rules

NO PURCHASE REQUIRED TO ENTER OR WIN.

1. **Eligibility:** The 2023 BOB FM Chillin And Grillin Giveaway is open to legal residents of Minnesota, Wisconsin and Iowa, who are 18 years of age or older at the time of entry. Employees and non-employee workers of The Butchery of Maple Lake, Milestone Radio LLC, Carpenter Broadcasting, StarCom LLC, Crystal Broadcasting and their respective parent companies, subsidiaries, affiliates, and agents and those prize providers and agencies that are involved in the development or execution of this giveaway or any of its materials, and the immediate family (spouse, parents, siblings, and children) and household members of each such person are not eligible. The giveaway is subject to all applicable federal, state, and local laws and regulations and is void outside the listed states and where prohibited by law.

4. **Promotion Period:** The giveaway begins at 8:00 a.m. Central Time ("CT"), February 6, 2023 and ends at 1:00 p.m. CT, March 10, 2023 (the "Promotion Period"). Milestone Radio LLC's computer is the official time-keeping device for this giveaway.
5. **How to Enter:** Entrants must submit an original photograph that must include a person who is grilling food of some kind on a grill. Photos must be taken during the promotional period to be considered. Entries must be submitted either at mybobcountry.com/bob-fm-chillin-grillin-giveaway OR on Instagram by going to <https://www.instagram.com>, logging into your Instagram account; posting your Submission along with the

Hashtag **#GrillinginBOBCountry** (the “Hashtag”) and Tag the **MyBOBCountry** account (**@mybobcountry**) (the “Tag”) on Instagram. Submission must be posted to the entrant’s non-private Instagram account; and MUST include the Hashtag and Tag to be eligible as an entry into the Contest. You must be a registered Instagram member to enter via the Instagram method of entry and you must be a follower of the MyBOBCountry Instagram account. Instagram account registration and Contest entry is free. Entries must be received between 8:00:00 a.m. CT, February 6th, 2023 and 11:59:59 p.m. CT, March 2nd, 2023. Alternate means of entry: Entrants can mail an original photograph that must include a person who is grilling food of some kind on a grill to “Chillin and Grillin Contest” 14443 Armstrong Blvd NW, Ramsey, MN 55303 during the promotional period. Limit One (1) entry per household.

6. Final Drawing: Administrator is an independent judging organization whose decisions as to the selection of the potential winners are final and binding. On Friday, March 3rd, 2023, five finalists will have their photographs selected by the administrator based on creativity, quality, presentation and effort. These finalists will have their photographs posted on mybobcountry.com to be voted on from 5:00 p.m. CT March, 3rd until 1:00 p.m. CT, March 10th, 2023. The finalist with the most votes at the end of the promotional period will be names the grand prize winner. The Grand Prize Winner will be announced at 8:00 a.m. CT on Monday, March 13th. The grand prize winner is responsible for pick up and transportation of the prize.
7. Requirements of Potential Winners: Potential winners must continue to comply with the official rules. Winning is contingent upon fulfilling all requirements. Winner will be requested to provide his/her phone number, address, and email address within 24 hours, so that BOB FM can establish contact.
