## The 2018 WALLS 102 Country Showdown at Starved Rock Lodge.

Registration to compete in the 2018 WALLS 102 Country Showdown at Starved Rock Lodge in Utica, Illinois opens **May 29th** and continues until **July 2 at 5 p.m.** 

The showdown consists of only one night of competition where a maximum of 12 contestants will compete for a place in the state competition. A "contestant" is one entry whether it is one individual or a group.

The 2018 Walls 102 Country Showdown will be at 7:00 p.m. on July 12th at Starved Rock Lodge (rain or shine)

Entry Fee: \$30 (Cash or Money Order only. NO CHECKS)

Entry Deadline: July 2nd at 5pm

We are only accepting 12 entries... first come first serve.

Must be 18 years or older to compete.

To register, print off the 2018 Country Showdown registration form at walls102.com. You may also receive a form by mail or at the offices of WALLS 102.

Registration will cease after we receive our first 12 entries. However, we will hold on to entries and notify you if your entry came through after the first 12 were received. Should your entry arrive after the first 12, we will keep a contestant "reserve" list in order of entries received after the 12th entry, and notify those individuals, in order, should one of our first 12 contestants back out of the 2018 Walls 102 Country Showdown for any reason. You will also be invited to attend our 2018 Walls 102 Country Showdown and be on "reserve" should we have any of our contestants not show up the night of the competition. Deadline to be put on the "reserve" list will be July 2nd at 5pm.

- Scoring is based 75% on judges votes and 25% on audience votes. All scoring is final and the judges have the final say.
- All contestants must sign-in with the WALLS 102 representative by 6:15 p.m. on July 12th.
- Contestants must be prepared to perform two songs.
- Music and lyrics must be memorized. No sheet music or words of any kind are allowed during the competition.
- CDs used as background music must be instrumental. We understand finding karaoke tracks for certain songs with NO vocals at all can sometimes be difficult. A CD with limited vocals during the chorus will be accepted, however judges may deduct points from your score for songs with excessive background vocals.
- All members of a group must be able to perform should the group advance to state or finals. If any member of the group is not able to perform or is replaced by someone else, by Country Showdown Rules, the act must be disqualified.
- One contestant will advance to the state competition for a chance to perform on national TV for the Country Showdown grand prize of \$100,000.

# Official Rules for the Country Showdown and The 2018 WALLS 102 Country Showdown at Starved Rock Lodge.

- 1. ENTRY PROCEDURE: You must complete this form and return it to the sponsoring radio station with your registration fee before their deadline date.
- 2. REGISTRATION FEE: TO ENTER THE COUNTRY SHOWDOWN A ONETIME REGISTRATION FEE OF \$30.00 PER ACT IS REQUIRED U.S. CURRENCY. THIS FEE IS TO BE COLLECTED ONLY ONCE, PER STATION, REGARDLESS OF THE NUMBER OF PERFORMANCES DURING THE COURSE OF COMPETITION. A CONTESTANT MUST PAY THE REGISTRATION FEE AND COMPLETE AN ENTRY FORM FOR EACH DIFFERENT RADIO STATION. VOID WHERE PROHIBITED BY LAW.
- 3. DISPUTES: The sponsoring radio station is authorized to resolve all disputes at their Showdown. CSI is the sole authority in resolving all disputes at the state, regional and national level competitions and to disqualify any contestant at any level of the contest for failure to comply with the rules and regulations including errors and omissions. CSI's decisions are final.
- 4. PERFORMANCE: The following applies to any Showdown contest:
  - a) Each act entered in the Showdown must perform only with the personnel listed on Sections 1 and 2 of the Entry Form. No personnel changes or substitutions will be permitted once local competition has been produced. Once an individual withdraws from an act at any level of the Showdown, he/she cannot perform at the next level.
  - b) Individuals may perform with only one act during any local Showdown.
  - c) A Radio Station may, at its discretion, provide a backup band for acts requiring instrumental support or allow contestants' pre-recorded music.
  - d) No live "backup band" vocals are allowed. Neither the backup band nor any of its members is permitted to compete in the Showdown in which they are the backup band.
  - e) Each act must perform live, vocally and/or instrumentally. No special lighting, props or special effects may be used.

- f) Any act with three or more individuals playing an instrument may not use the backup band or any part of the backup band, or pre-recorded music.
- g) The amount of performance time given to each local Showdown contestant will be determined by the local radio station.
- h) All performances must be done in good taste: no music or lyrics that the radio station or CSI considers offensive may be performed.
- i) Age restrictions will be at the discretion of the radio station and/or its venue.
- j) Contestants may perform their own music and receive extra bonus points from the judges. Music eligible for bonus points will be defined as any piece of music written or co-written by the contestant (either individual or member of group). Any contestant (either individual or member of group) who claims to be using his own music may be disqualified at any level of the contest at the discretion of CSI if a musical copyright for the music exists which does not name the contestant as author or co-author.
- k) Acceptable documentation to prove ownership of your music shall include either a certificate of copyright, proof of song registration with BMI, ASCAP, etc., or a notarized copy of the music.
- Performances will be awarded 0-10 points in each of the following categories: 1) Overall Talent

   Marketability in country music; 3) Vocal/instrumental ability; 4) Originality; 5) Stage
   presence/ charisma; 6) Talent. An optional bonus of up to three points may be awarded for acts
   performing their own music.
- m) In the event of a tie, the first tie-breaker shall be the highest number of points given in the Talent category. The second tie-breaker shall be the highest number of points awarded in the Marketability category. The third tie-breaker shall be by secret vote of the judges based on overall performance style and impact.
- 5. LOCAL CONTEST PRIZES: The only official prize offered at the local Showdown level is the opportunity for the winner to advance to the state Showdown competition. Local Showdown contestants must pay their own expenses during the competition at the local, state and regional levels. In signing this Entry Form, the Showdown contestant acknowledges that neither CSI nor any national sponsor is responsible for any prizes promised or offered at the local Showdown contest level (except for the local Showdown winner's chance to compete in the state Showdown competition)

#### Official Rules of WALLS 102 contests
