# City of Benton Harbor – Water System Loss of Pressure WATER SYSTEM LOSS OF PRESSURE – DO NOT DRINK

Due to a large water pipe break on Klock Road around 4:00 PM on Wednesday 10/20/2021, the Benton Harbor water system is currently without water service. During a loss of pressure, bacteria may enter the water system and the safety cannot be assured. In addition, water is not available for washing and bathing. Bacteria are generally not harmful and are common throughout our environment. However, a failure of pressure can allow disease causing bacteria to get into tap water. Corrective measures are currently being undertaken to fix the break as soon as possible, and restore water service.

#### What should I do?

Continue to use bottled water for drinking, making ice, brushing teeth, washing dishes, and preparing food at this time, and after water is restored until filters are approved for use.

Tap water may be used for washing and bathing after pressure is restored, and after flushing your taps including sinks and bathtubs for 5 minutes. However, care must be taken to avoid getting the water in your mouth during bathing, or children's mouths when bathing them.

If you have a severely compromised immune system, have an infant, are pregnant, or are elderly, you may be at increased risk and should seek advice from your health care providers about drinking this water. If you believe drinking the water has made you ill, please contact a physician immediately.

## What happened? What is being done?

These precautionary actions are being taken due to a large water main break, resulting in the loss of water service to the City. Following the repairs, water service will be restored. Samples will be collected to determine if the water quality meets the state drinking water standards for bacteria. We anticipate restoring water service within one day, and we will notify water customers of sampling results for bacteria.
