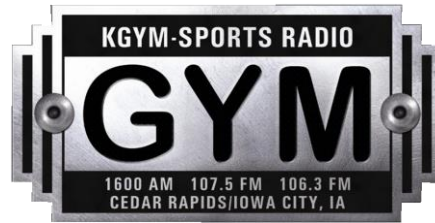


Cyclone Math Official Contest Rules

- 1) No purchase is necessary to enter contest and claim prize. Entries must include all required information based on method of entry at the management site listed in (5) Method of Entry.
- 2) **CONTEST DATES:** Contest runs Monday, December 7th, 2020 through Friday, December, 11th, 2020.
- 3) **CONDITION OF PARTICIPATION:** Materials submitted become property of KZIA, Inc. Winner may be required to execute an affidavit of eligibility and name and likeness publicity release and a waiver and release of liability. By participating in this contest, participants agree to be bound by these rules. The decision(s) of judges provided by KZIA, Inc., will be final. All taxes and any registration fees or deposits are the sole responsibility of the verified winner. If prize includes travel with a traveling companion, traveling companion must also be age 21 or older and also complete the waiver and release of liability form and the name and likeness publicity release.
