



## **KZIA Contest Rules**

- 1) No purchase is necessary to enter the contest and claim prizes.
- 2) **CONTEST DATES: Tuesday, May 6, 2025, at 6:30 a.m. to Friday, May 9, 2025, at 9 a.m.**
- 3) **CONDITION OF PARTICIPATION:** Materials submitted become property of KZIA, Inc.
