

## **Christmas Cash Game Rules**

HJV Limited Partnership and its subsidiaries and affiliated companies (together, “VerStandig Media” or the “Station”) is conducting the following contest on Station WAYZ (FM), Hagerstown, MD:

### **1. Contest Dates:**

Christmas Cash Game will begin on October 22, 2018 and end on or around December 7, 2018.

### **2. How to Enter/Win:**

Go to wayz.com, click on the contest link, and fill out the entry form to enter. If you do not have internet access, you may mail your information including full name, address, phone number, and birth date to 104.7 WAYZ, Attention: Christmas Cash Game, PO Box 788, Greencastle, PA 17225. During the time contest is being run, each non-holiday, weekday between 8am and 9am, 10am and 11am, 2pm and 3pm, and 4pm and 5pm, one name will be chosen from the total number of entrants and announced on air. Each name announced has 15 minutes from the time the name is announced to call 888-950-1047 to win one hundred dollars (\$100.00). If the person identified on-air fails to call within fifteen (15) minutes, the process will repeat once more. If the second person identified on-air fails to call within fifteen (15) minutes, there will be no winner for that prize round. All contestants from the “WAYZ On Tour” contest are already entered into this contest.

### **3. Eligibility and Limitations:**

Each winner must be U.S. residents, must have a legal driver’s license or other form of government issue identification which confirms both their name and the address which has been announced on air, and must each be at least 18 years old as of the date of the contest episode in which the prize is won, as determined by the Station. Current employees of VerStandig Media, their advertising agencies, employees of other radio and television stations in the Hagerstown, MD/Chambersburg, PA market, and members of the immediate family of any such persons are not eligible to participate and win. The term “immediate family” includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as “in-laws,” or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household, whether or not related. One entry per person for this contest. Listeners are able to win as often as their name is drawn.

### **4. Prizes.**

Each winner will receive a check for One hundred dollars (\$100.00). There will be approximately 140 winners.

Please allow approximately 5-7 business days from the actual win date to pick up the prize. The Prize must be picked up in person by the winner listed on the prize sheet and they must present valid photo identification, including the address announced on air, acceptable to The Station in order to claim the prize, no prizes will be mailed. The Prize may be picked up during normal business hours (Monday-Friday, 8:30am – 5:00pm, excluding holidays).

### **5. Publicity; Use of Personal Information.**

Each participant, and each winner grant VerStandig Media permission to use their name, voice recording, photograph, picture and other likeness picture or other likeness in any advertising or broadcasting material relating to this and any other VerStandig Media contest or promotion for a period of two years without royalty, remuneration, or other compensation, and agrees to sign a publicity release in this regard prior to acceptance of the prize. **[By participating in the Contest, where allowed by law, each winner agrees that VerStandig Media may disclose a winner’s name and address to third parties and to use such information for marketing and other purposes.]**

### **6. Receipt of Prize and Release.**

By accepting the prize, each winner waives any and all claims of liability against HJV Limited Partnership t/a VerStandig Media, its officers, principals, directors, employees and agents, for any personal injury or loss which may occur arising directly or indirectly from the award of the prize or participation in the contest, including the use and operation of the grand prize. In order to receive a prize, participants must establish eligibility, identity, and sign a receipt of prize and an official waiver form provided by the Station. Contest sponsors may require a separate waiver and release.

### **7. Taxes.**

Any valuation of the prize stated in these rules is based on available information provided to the Station. The value of the prize awarded to each winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes related to the prize won and paying any expenses associated with any prizes which are not specifically provided for in these rules. Each winner must provide VerStandig Media with valid identification and a valid social security number before any prize will be awarded. Any person winning over \$600 in prizes from VerStandig Media during a calendar year will be reported to the IRS and will receive an IRS Form 1099 with respect to such winnings.

### **8. Conduct and Decisions.**

By participating in the Contest, participants agree to be bound by the decisions of the Station and its personnel. Anyone who violates any rule, gains unfair advantage in participating in the Contest, or obtains status as a winner using fraudulent means will be disqualified. Unsportsmanlike, disruptive, annoying, harassing or threatening behavior is prohibited. VerStandig Media reserves the right to seek civil damages and/or criminal prosecution to the fullest extent permitted by law in connection with attempt by an entrant or any other individual to deliberately circumvent, disrupt, damage, or undermine the legitimate operation of this Contest. VerStandig Broadcasting will interpret these rules and resolve any disputes, conflicting claims, or ambiguities concerning the rules or the Contest and the decisions of VerStandig Media concerning such disputes shall be final. The Station is not responsible for typographical or other errors in the printing, the offering or the administration of the contest or in the announcement of any prize. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference, or any event beyond the control of the Station, VerStandig Media reserves the right to terminate this Contest or make such other decisions regarding the outcome as it deems appropriate, and such decisions shall be announced on air and/or through notification to each winner. The Station may waive or change any of these rules in its sole discretion including but not limited to contest dates, amount or value of the prizes, execution of the contest, or instructions on how to enter and win.

### **9. Miscellaneous.**

This Contest is void where prohibited. Odds of winning depend upon the number of participants. The Company may substitute prizes, amend the rules or discontinue the Contest at any time following broadcast on the Station of such changes.
