

DETAILED CONTEST RULES “VIVA LA MEXICO VACATION GETAWAY PROMOTION”:

1. How to Enter the Contest:

- a. The “Viva La Mexico Vacation Getaway” contest will begin on Monday, September 13th and end on Friday, November 19th 2021.
- b. To participate in the contest, listen for the Keyword of the Day on WWFY/WJKS, WRFK/WWFK, or WSNO, and then text the Keyword to that station’s text line.
- c. Entrants may be disqualified at the sole discretion of Great Eastern Radio, LLC.

2. Eligibility Restrictions:

- a. The contest is open to all contest participants who are 21 years of age or older and legally reside in Vermont, New Hampshire, or New York.
