

12 TRIPS OF CHRISTMAS RULES

US 96 **12 Trips of Christmas** event will take place Saturday, December 8, 2018 at the Lady Luck Casino in Vicksburg. The registration will open up at 3:00 pm and will close promptly at 4:00 pm on December 8, at the Lady Luck Casino, in the Lone Wolf Lounge location. Anyone who is not in the registration line by 4:00 pm will not be allowed to enter the contest. All potential participants must show picture ID confirming that they are 21 (twenty-one) years of age or older in order to participate.

For showing up and registering, each participant will receive one ticket (entry). If a participant has the US96 app on their phone, then they get an additional ticket (entry). If a participant is a member of the Lady Luck Fan Club, then they will get one more additional ticket (entry). Those who are members of the Lady Luck Fan Club, must have their fan club card and valid picture ID at the registration.

There will be a prize wheel in or near the Lone Wolf Lounge. On the prize wheel will be multiple slices. Twelve (12) of the slices will be trips. The remainder will be such things as meals or other miscellaneous other gifts of lesser value. All qualified participant tickets will be placed in a pot to be drawn. If a participant's name is drawn, then that participant will be given the option to choose a stocking stuffed with a \$250 Gift Card to area merchants or a chance to spin the wheel of trips. The participant's choice is final. Once the participant is handed the stocking with the Gift Card or chooses the chance to spin the wheel, the participant can't change their mind. If the participant chooses to spin the wheel then the participant wins the prize on which the wheel stops. Prizes won are final. Prizes cannot be substituted or transferred to another person. The valid ID must be out and ticket presented to the Marketing Representative within 1 (one) minute in order to participate in the contest. Once the winner is called and that player fails to produce their ticket (entry) within the allotted time, the winner has forfeited any chances of winning again for that contest (a winner is described as a person or persons that have been called to received an unclaimed prize(s).
