

## **DETAILED CONTEST RULES “MORTGAGE FREE FOR ME”:**

### 1. How to Enter the Contest:

- a. The “Mortgage Free For Me” contest will begin on Monday, April 22<sup>nd</sup> 2019 and end on Friday, June 28<sup>th</sup> 2019
- b. To participate in the contest, text the solicited keyword, be correct caller when solicited, or enter on station’s Facebook page when solicited on respective station (WHDQ, WTSL, WXXK, WGXL).
- c. Entrants may be disqualified at the sole discretion of Great Eastern Radio, LLC.

### 2. Eligibility Restrictions:

- a. The contest is open to all contest participants who are 21 years of age or older and legally reside in Vermont, New Hampshire, or Massachusetts.
- b. Employees, officers, and directors of Great Eastern Radio, LLC, its advertising agencies and promotional companies involved in this promotion, as well as family and household members of same, shall be ineligible to participate in the promotion and shall be ineligible for any prize covered herein.

### 3. Prizes:
