Malcomb McBride-Townsend of Malden, Missouri who is charged with the crime of Murder 2nd Degree-Felony Murder-During the Perpetration/Attempted-Perpetration/Flight from Perpetration of a Felony, a person dies, who is charged with the crime of Assault 1st Degree or Attempt-Serious Physical Injury or Special Victim, the defendant (**McBride-Townsend**) willfully and unlawfully committed, **COUNT I-CLASS A FELONY MURDER IN THE SECOND DEGREE & COUNT II-CLASS A FELONY ASSAULT IN THE FIRST DEGREE OF DANTE GIBSON. NO BOND**

Jordan Paul Morgan of Bernie, Missouri who is charged with the crime of Murder 2nd Degree-Felony Murder-During the Perpetration/Attempted-Perpetration/Flight from Perpetration of a Felony, a person dies, who is charged with the crime of Assault 1st Degree or Attempt-Serious Physical Injury or Special Victim, the defendant (**Morgan**) willfully and unlawfully committed, **COUNT I-CLASS A FELONY MURDER IN THE SECOND DEGREE & COUNT II-CLASS A FELONY ASSAULT IN THE FIRST DEGREE OF DANTE GIBSON. NO BOND**

Jalen Dashawn Miller of Malden, Missouri who is charged with the crime of Murder 2nd Degree-Felony Murder-During the Perpetration/Attempted-Perpetration/Flight from Perpetration of a Felony, a person dies, who is charged with the crime of Assault 1st Degree or Attempt-Serious Physical Injury or Special Victim, the defendant (**Miller**) willfully and unlawfully committed, **COUNT I-CLASS A FELONY MURDER IN THE SECOND DEGREE & COUNT II-CLASS A FELONY ASSAULT IN THE FIRST DEGREE OF DANTE GIBSON. NO BOND**

It should be noted, all defendants listed in this news release are innocent until proven guilty in a court of law.
