JOINT ORDER ON TRAVEL AND SOCIAL DISTANCIG PROCEDURES IN PUBLIC FACING LIFE SUSTAINING BUSINESS

Joint Executive Order 04-06-2020

WHEREAS, Andy Beshear, the Governor of the Commonwealth of Kentucky declared a State of Emergency on March 6, 2020 in response to the COVID-19 pandemic; and

WHEREAS, Donald J. Trump, President of United States declared a National State of Emergency on March 13, 2020 in response to the COVID-19 pandemic; and

WHEREAS, Hollis L. Alexander, Judge/Executive of Trigg County Kentucky declared a State of Emergency on March 13, 2020 in response to the COVID-19 pandemic; and

WHEREAS, Todd King, Mayor of the City of Cadiz Kentucky declared a State of Emergency on March 13, 2020 in the response to the COVID-19 pandemic; and

WHEREAS, the COVID-19 pandemic has resulted in emergency actions occurring daily: and

WHEREAS, Trigg County and Cadiz local governments have the responsibility to protect the public health, safety and welfare, and to mitigate the efforts of such events

NOW, THEREFORE, For the purpose of maintaining social distancing under the CDC guidelines and to promote the health and well-being of the general public to reduce the community spread of disease, in response to the Novel Coronavirus (COVID-19); and pursuant to KRS Chapter 39A and 39B; and to ensure that persons and groups disperse from the scene of the emergency; and to promote and secure the safety and protection of the civilian population in Trigg County and Cadiz. I, Hollis L. Alexander, Trigg County Judge/Executive and I, Mayor Todd King, City of Cadiz Mayor, by the virtue and powers and authorities vested in us as Trigg County Judge/Executive and City of Cadiz Mayor pursuant to Kentucky Revised Statutes chapters 39A and 39B, and executive orders issued by the Governor of the Commonwealth of Kentucky, do Hereby Order the following:

- In addition to travel restrictions ordered by Kentucky Governor Andy Beshear's
 Executive Order 2020-266 sections 8 and 9, anyone coming to reside/stay in Trigg
 County and/or the City of Cadiz who are currently located in another state, other than
 for the exclusions in the Governor's executive order, shall report their presence to the
 Trigg County Health Department and self-quarantine for 14 days.
- All public facing life sustaining businesses that remain open shall develop and enact procedures that:
 - a. Immediately impose limits of one (1) person from a family or group in the business at any given time. This order excludes minor dependent children of the

parent/guardian when no other option of childcare is available. This order also permits one (1) adult to accompany and assist those customers with disabilities and elderly customers who require assistance.

- b. Beginning Tuesday, April 7, 2020 at 12:01 AM impose limits not to exceed five (5) customers per 1,000 square feet of the facilities retail shopping space at any given time.
- c. Beginning Tuesday, April 7, 2020 at 12:01 AM institute one-way movement through the business's aisles using floor markers and/or signage indicating the customers proper
- directional movement through the retail area of the store.
- d. Report non-compliant or unruly customers to the Trigg County Sheriff's office or the City of Cadiz Police Department.
- 3. Owners and/or managers of all public facing life sustaining businesses that remain open assume the responsibility of ensuring compliance with this Executive Order. This Order shall be enforceable by the Trigg County Health Department, and if necessary, the appropriate law enforcement agency.
- 4. All prior executive orders pursuant to the declaration of emergency remain in full force and effect.

This order shall be effective on Monday, April 06, 2020 at 12:01 AM and shall remain in effect until further notice or when it is determined that a state of emergency no longer exists and the exercise or extraordinary measures are no longer required for the protection of public health, safety, and welfare of the citizens of Cadiz and Trigg County
