#### **HELPING THOSE AFFECTED BY RECENT OIL SPILL**

An oil spill occurred on October 4 from an underwater pipeline owned by Houston-based Amplify Energy Corporation off the coast of California. The cause of the spill is yet unknown, with some speculation pointing the finger at a cargo ship that was docked in the area prior to the spill. The ship made several unusual movements, leading to speculation that it might have impacted the pipe causing a breach.

Although Amplify worked quickly to stop the leak, more than 100,000 gallons of oil spilled into the ocean and reached the shores of Huntington Beach. The spill left a swath of oil along the beachfront. It impacted Huntington Beach, as well as the Santa Ana River Trail and Talbert Park.
